1. Significance of the research problem in scientific and applied terms.

In a rapidly changing global environment, in which the interactions between countries and their regional groupings are becoming increasingly complex, the study of the mechanisms of regional economic integration is of particular importance. The rise of regional trade agreements, the challenges posed by rising protectionism, and trends towards de-globalization highlight the importance of regional integration as a key factor for economic development and sustainability.

Scientifically, the dissertation not only adds to the existing literature on the topic, but also challenges traditional theories of economic integration, highlighting the need for new approaches. The author proposes innovative solutions that reflect contemporary realities by introducing a three-dimensional assessment of integration processes and a new typology of integration agreements. By identifying the main mechanisms of integration and analyzing their impact, the work offers practical guidance that can help countries adapt their economic strategies and promote sustainable development in the context of global economic transformations.

2. Justification of the aims and objectives of the thesis.

The aims and objectives of the dissertation of Assoc. Marinov are formulated with the necessary clarity and logic, which underlines his thorough understanding of the research topic. The author has successfully identified the key aspects of regional economic integration that need to be addressed in order to achieve a thorough scientific study and practically applicable analysis.

The main objective of the dissertation is to explore the dynamics of regional economic integration and to propose new conceptual frameworks for assessing integration processes. They include an examination of structural changes in world trade, a critical review of the existing literature, an analysis of empirical data and case studies to assess the practical implications of regional integration, and the development of a new conceptual framework for the assessment of integration processes. All of these elements are essential for achieving significant scholarly and practical contributions, providing the depth and breadth of analysis needed to reveal the complexity of integration processes.

3. Relevance between the chosen research methodology and methodology and the stated aim and objectives of the dissertation.

The chosen methodology and research methodology in the dissertation of Assoc. Marinov are perfectly consistent with the formulated aims and objectives. A multidisciplinary approach is used, which is mainly based on economic concepts, but also integrates methods from political science and international

Marinov manages to identify key factors and trends that influence integration processes. The study provides an in-depth and comprehensive examination of the challenges and opportunities associated with regional economic integration, and thus provides valuable guidance for policies and strategies applicable in the context of the contemporary global economic architecture.

4. Scientific and applied contributions of the dissertation (description and evaluation), including the presence of original contributions to science.

The author stresses the need to adapt theoretical frameworks to contemporary realities, which is essential for the development of the scientific field.

5. Assessment of publications on the dissertation: number, nature of the publications in which they have been published.

The dissertation of Assoc. Marinov's dissertation is supported by an impressive number of publications that reflect his long-standing research interest in the topic of regional economic integration. The total number of published works related to the dissertation is thirteen, covering various aspects of trade policies, integration and economic change in a global context.

which is reflected in a number of citations in various scientific articles and studies related to the topic of regional economic integration, economic policies and trade relations. The citation of his works in reputable scientific journals testifies to the validity and relevance of the conclusions he proposes.

7. Opinions, recommendations and comments.

The dissertation of Assoc. Eduard Marinov represents a significant study in the field of regional economic integration and provides an important contribution to both the scientific literature and the practical application of national strategies for participation in integration processes. In spite of the high level of the work, I would allow myself some recommendations that do not alter the achievements of the dissertation.

First, I would suggest that the author continue to develop the conceptual framework he has put forward in the dissertation. It demonstrates originality and is suitable for application in empirical research. Broadening the theoretical foundation and incorporating concrete data and real-world examples would contribute to a more complete understanding of the dynamics of integration. Second, I recommend that Assoc. Marinov to pay attention to integrating the views of practitioners in the field of economic integration. Conducting interviews with experts and representatives of governmental and nongovernmental organizations could provide additional value and confirm the practical applicability of the study's findings. Next, I would recommend that the author specify the specific methodological approaches used to select the case studies he analyzes. This will help the reader to better understand the choice of specific examples and how they illustrate broader trends in integration processes.

Finally, I would recommend Assoc. Marinov to continue publishing articles based on the new theoretical framework proposed in the thesis in international academic journals. This would increase the visibility of his research in the global scholarly arena and contribute to broadening the impact of his work, as the topic has relevance beyond the local context and is of particular importance for understanding contemporary economic interactions and integration processes.

8. Conclusion with a clearly formulated positive or negative evaluation of the thesis. The scientific and applied contributions of the dissertation are significant, offering new perspectives and contributions that enrich the existing literature. The author develops a new conceptual framework for analyzing the multilayered nature of contemporary regional economic integration that is original and adapted to current challenges in the current global economy.
